MEMBERSHIP TRANSFER AUTHORIZATION

**Transferor** hereby surrenders Membership in the LCWSC by execution of this form. Water service rights granted by membership and other qualification hereby cease contingent upon further qualification of the Transferee in accordance with the policies of the LCWSC. By execution hereof, the undersigned hereby acknowledges that the Membership Transfer complies with the terms of one of the following items:

1. The Membership is transferred by will to a person related to the Transferor within the second degree by consanguinity or
2. The Membership is transferred without compensation to a person related to the Transferor within the second degree by consanguinity or
3. The Membership is transferred without compensation or by sale to the Corporation or
4. The Membership is transferred as part of the conveyance of real estate from which the Membership arose.

**Transferee** understands that qualification for Membership is not binding on the Corporation and does not qualify Member for continued water service unless the following terms and conditions are met:

1. This Membership Transfer Authorization Form is completed by the Transferor and Transferee.
2. The Transferee has completed the required Application and Service Agreement.
3. All indebtedness due the Corporation has been paid. In the event normal collection procedures do not clear transferor's obligation to the Corporation the transferee agrees to pay any debt left on this account.
4. The Transferee demonstrates satisfactory evidence of ownership of the property designated to receive service and from which the Membership originally arose.
5. Any other terms and conditions of the Corporation's Tariff are properly met.
6. In the event Transferor requests a membership transfer, the Corporation shall require the transferee to deposit with the Corporation additional membership fee to equal that quoted in the Corporation's current bylaws.
